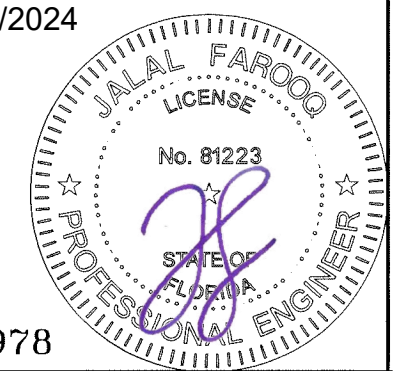


DOOR WITH THRESHOLD
